# Words from Their Excellencies Hrolf and Madelaine

Greetings all,

We are looking forward to attending our Barony's 20th birthday this coming weekend. Our Barony still grows and prospers in these lands, and we are very pleased and grateful for those who are willing to work towards holding events, practises and activities. Also, we remind everyone that the group runs on the good will of all who volunteer, and that those volunteers can always do with a helping hand. Everyone matters to Us in this regard.

Baroness Madelaine, along with Lady Morwenna as her protégé, visited the Barony of Stormhold last weekend to witness the change-over of the Baronial Coronet. Baron Karl Faustus ('Batty') and Lady Adelindis and their children also attended from Ynys Fawr.

Baron Hanbal and Baroness Ute stepped down from their tenure as B&B Stormhold, and in their place King Niall and Queen Liadan appointed Mistress Antonia de Lorenz as the new Baroness to serve as Their representative in Stormhold. The event was similar to a ball, with continual servings of delicious hot and cold dishes (buffet style) along the groaning board for attendees to serve themselves as they desired, and casual seating enough so that people could dance in the centre of the hall or gather in socialising groups either standing or seated, also with various entertainments of instrumental or chorister presentations for the delight of the crowd. About a dozen families brought their children who played happily amongst the crowd or seated quietly for Court, many were members of the Crown's Mouse Guard, and a new member was also appointed at Court from amongst those children. Many other people were recognised for their achievements, in particular Karl Faustus receiving an Augmentation of Arms.

Proceedings at the Royal Court were in three stages with good intervals between each. At the first session, The crown greeted the populace, and then allowed Baron and Baroness Hanbal and Ute to conclude their reign with their last Court and the Crown accepted their retirement of the Stormhold Coronets, followed by and interval, then the Crown conducted the induction of the new reigning Baroness Antonia, who appeared in the finest array of peals and gems adorning her regal outfit in the Byzantine style, and all were suitably impressed. She took her place in Court on a throne alongside the King and Queen, and then followed another interval. When the Royal Court resumed, Her Excellency Baroness Antonia appointed her retainers, including a food taster and a "nay"-sayer, so that she may be kept safe from poisoners and that there be someone (as she reigns without a Baron) who is officially allowed to deny her whims so that she may remain on course to serve the Barony without falling ill to overwork.

For my part I greeted the new Baroness Stormhold as Baroness Ynys Fawr, gifting her with a personal gift in friendship, and giving greetings from Baron Hrolf, also remarking that he sends his greetings as the Admiral of the Southern Seas. This was in response to remarks about ships and privateers being in the area. Ynys Fawr was not forgotten in the proceedings, as we were given a place on a throne at Court alongside Their Excellencies Cormac and Elspeth, Baron and Baroness Crae Glas, to witness the proceedings as befits Our stations.

I would like to thank Lady Morwenna for serving me as my lady in Waiting during that event, so that I was able to come and go as I needed to. It was also very pleasing and reassuring to have been greeted by Baron Rodrigo, whose Fez would have made Baron Hrolf very envious in the heights that it reached. Rodrigo saw to it that I was well acquainted with the Crown Rooms and the layout of the event.

Laurel has once again ruled on certain submissions from the College of Heralds of Lochac. Here's the good news:

- \* Eliza de Horsley. Device. Gules, a horse passant contourny and a bordure embattled Or.
- \* Godric von Eichsfeld. Name.
- \* Kiara de Fae. Device change. Per pale sable and argent vêtu ployé vert, an estoile counterchanged.

Sadly, there were also some returns. Thyri skjaldmaer, Rocket Herald, will be in touch to discuss this shortly.

Now for some news that some people have been waiting for.

As you know, heraldic submissions of devices and badges must be coloured in using good quality textas (marker pens, if you're not Antipodean) and you need six colour copies and one in outline: one colour copy for yourself, one for your consulting herald, and four plus the outline copy for the submissions process. Colour printing, whether inkjet or laser, and colour photocopies, are not acceptable, due to the very real possibility that the colours could shift over time -- reds turning orange, greens turning brown, purples turning fuchsia and other colours degrading in counter-intuitive ways. So every submission requires an insane amount of colouring-in.

Six months ago, Master William Castille approached me about this situation, and asked permission to run a test. The knowledge we have of printer and copier technology is old, and it wouldn't be appropriate to allow policy to remain unchallenged, so with the Laurel King of Arm's agreement I approved the test.

William conscripted several volunteers all around the kingdom and produced a testing regime of reasonable scientific integrity. He examined the performance of various colour printers compared to textas, subjected to various weather conditions over a suitable time period.

When he finished, he summarised his results thus: that the colour-fastness of colour printing is equal or superior to that of the texta inks under identical conditions.

I have therefore advised Thyri Rocket, my submissions deputy, to allow colour printed versions of device and badge submissions from this moment on, under certain conditions.

First: no colour printed submission will be accepted unless it includes clear and complete information about the technology used to produce it: colour printer or photocopier make, model and age, and the source of the inks or toners, whether original or generic remanufactured. This information allows us to continue the experiment and gather essential information.

Second: if, by the time the submission reaches Rocket Herald or Laurel King of Arms, it has degraded or shifted significantly, it will be returned for a redraw, and Rocket Herald will not accept the redraw done using the same technology. So if your colour print doesn't cut the mustard, its back to textas for the redraw.

Finally, this rule will be eternally probationary. If we discover that certain types of hardware are not up to scratch, the ban on colour printing and copying will return in part, perhaps limiting the technology (inkjet, laser, etc), or even in full. This will be notified in the usual way. We will also maintain a page on the Herald's website where you can track the performance of the various technologies.

I am sure this will come as a relief for everyone, especially those who, like me, hate colouring-in with a passion.

\*The questions:\*

\*What makes an event official?\*

\*SCA corpora <http://www.sca.org/docs/pdf/govdocs.pdf%3E>\* section IIA states that "All Society events must be sponsored by branches of the Society, registered with the Seneschal of the sponsoring branch, publicised at least to the members of that branch, and conducted according to Society rules." So an event must be approved by the group seneschal and advertised to the group as an SCA event, and it must comply with all rules such as collection of indemnities, marshallate rules for fighting, etc. For further enquiries about the details of how this is administered, please contact the kingdom seneschal.

\*Can we have an official meeting in one room while our friends have an unofficial practice in another room?\*

The SCA Ltd does not have unofficial events. If the event has been officially approved by the group seneschal, then it is an official event and requires insurance.

If the venue is hired by the SCA (or in any way uses the SCA name in order to hire the venue) then it all has to be covered by SCA insurance and therefore everything done on the site must be run by SCA rules. If, in the unlikely event something goes wrong for a third-party or damage is done to a venue, you would want the SCA Ltd's insurance to cover costs (instead of being liable for all costs associated with damage or injury or obtaining your own public liability insurance) then you need it to be an official event with waivers and \$5 from non-members.

To hold a practice adjacent to an official meeting/event/activity, or in the same time and place as a regular activity is normally held is likely to cause confusion and imply that the practice is part of the SCA meeting. If the activity could be very easily confused for an official SCA activity, then the activity must be run as an SCA event and comply with SCA rules.

If the official SCA activity is clearly separated from a private activity (e.g. an event followed by a member issuing an invitation to everyone present to "come back to my place for coffee") then the private event will not be an SCA event and will not be covered by SCA Ltd insurance, and will not be able to use SCA assets (e.g. archery equipment, pavilions) except where borrowed under the same arrangements any group outside the SCA might make.

\*Can me and a few friends just practice combat in a park unofficially?\*

While SCA Ltd cannot regulate what members do on their own time, as long as no impression is given that this is an SCA event, and no SCA resources are used (ie SCA insurance or name is not used to hire a park), practising combat in a public place could be a very bad idea for a number of reasons.

Firstly, if a bystander is injured as a result of the combat practice, SCA insurance does not cover the combatants because it was not an official event, so the individuals could be sued for injuries.

Secondly, a number of members of the public can be quite concerned by the use of weapons in a public place, and there have been instances in the past of the public calling the police regarding an SCA event. Most explanations of what you were doing with weapons in the park involve using the name of the SCA, and thus your unofficial activities

still reflect upon the reputation of the SCA. In some states actions which link weapons use with the SCA may severely endanger our ability to maintain an exemption that permits us to own certain weapons (even if these were not the weapons practiced with), such as swords, that would be illegal for general members of the public. SCA Ltd will not support members in negotiations with authorities regarding weapons usage at non-SCA events.

In other cases, members of the public have complained to venue hirer (i.e. the local council) about weapons use at an event. Where the local council has been forewarned that weapons use will occur at an event, and that safety standards are in place, they can reassure the public. For an unofficial event, where the hirer has not been informed, a stronger reaction is likely, and the SCA may find it difficult to hire the park for legitimate events in the future as the result of complaints about what a few of its members did on their own time.

In the light of the above, the SCA Ltd strongly advises it's members to consider if their private actions of practicing weapons in a park to take care in ensuring that their actions are clearly not linked to the SCA, remember that no insurance coverage will be available, and advises that no activities are undertaken where the event/activity might impact upon the SCA.

\*What does the insurance actually cover?\*

SCA Ltd insurance cover notes can be found on the board website at

http://sca.org.au/board/index.php?page=governance

Basically the policies cover participants against their damaging property or bystanders as a result of doing normal SCA activities.

The policy also covers the organisation for a number of crippling major incidents that could occur, for example above excess costs if we have an expensive tax investigation, loss of large amounts of money as a result of a crime (fidelity insurance), and the policy insures directors against poor decisions made with the best intentions and diligence, which ensures we get higher quality candidates for board positions, not only those who own no major assets (like a house which could be claimed in legal actions) or are unaware of the risks.

The insurance policy only covers anyone while they are following the SCA rules (including all marshallate and waiver rules), at SCA events which have been properly approved.

\*Does a non-member who is present at a non-demo event have to pay the event membership if not participating in the event?\*

A person conducting their normal business within the venue of an event or meeting as they would when the SCA was absent (eg a tradesperson conducting work, a venue owner, a dog walker in a park) is not considered to be present at an event, as long as they do not do any actions other than their normal business. Under these conditions, no event membership is payable.

A key determining factor for non-participation is if the person would have been at the location regardless of if the event/activity were occurring. For example a number of SCA members may attend a fighter training, despite not being combatants, in order to socialise with other non-combatants. These people would not have been at the location if the fighter training were not occurring, so are participating in the event.

In a public place, a bystander who chanced upon a tournament could ask a few questions about what the SCA was at the edge of the event, but as they participated in the event more than a spectator would at a demo (for example swinging a sword, even at a pell), then they would need to sign in to the event and pay an insurance fee.

If a meeting was held in a private residence, another (not the SCA host) resident of the place who does not participate in the SCA might be able to wander into the room, chat with participants a little, but should not undertake any activities. The non-SCA resident would be at the location of the residence (their home) regardless of the SCA meeting.

Non-members who have attended SCA Ltd events before as members/event members will not be considered bystanders as they can be assumed to know enough about SCA rules to know an event membership is required.

From Lochac's new Earl Marshal.

Now - to let you know about a few upcoming issues.

New Marshals Handbook. This is now our marshalling guidelines.

Everyone will need to read this several times.

New Marshal Authorisations

All current Marshals will now be Marshals (section 2.2.3).

All current Knight Marshals (Baronial and Shire) will be automatically upgraded to Senior Marshal (section 2.2.4). I will ask the Knight's Marshal to provide a short list (around five or six) of experienced and active Marshals in their groups to be upgraded now.

Can the Knights Marshal send me their nominated lists and we can get the new authorisations sorted.

Future upgrades will happen as per the new/current handbook procedures.

Until we get the new authorisation set up we will not be accepting new combat authorisations (this is only a week or so let me know if this is an issue).

#### KOLCH

We will be working on a revamp of the current Kingdom Combat and Armour standards. I will say that this will be a significant change and hopefully a good one.

And before anyone asks. There will be no major changes to our war rules.

#### **Online Reporting**

I have stated some discussion with the tech folk about introducing online reporting forms. This will basically mean group marshals just fill out an online form and hit send as their report. We will also be looking at a critical incident reporting form to cover notifyable events.

#### YouTube Tutorials

I am keen to produce a number of videos demonstrating armour inspections and other such procedures so we can get common practices throughout the Kingdom. This was started by Duke Siridean and is a great idea.

#### Deputy

I have asked Countess Eva von Danzig to be my drop dead deputy (she said yes). I will be asking several other people to assist with given projects. If you are keen to help out, let me know.
